#### Purpose

The purpose of this document is to provide technical instructions to Covered Reporters on how and where to submit their data, data file formats, file structure and headers, submission validity checks, and examples of correctly submitted data.

### **Data Submission**

All respondents must submit their completed report using the Federal Reserve System's EFeDS. Covered Reporters will receive technical transmission requirements and guidance from the Federal Reserve Bank of New York (FRBNY). The FRBNY will also provide technical assistance to respondents on using this system. Covered Reporters can contact FRBNY Statistics Business Technology Support at 212-720-2999 or email <u>nyasd.inbox@ny.frb.org</u> for assistance.

## Data Format, File Structure and Header Information

For the data's file format, the file's structure, and header information, please consult *Instructions for Preparation of the Report of Centrally-Cleared Transactions in the U.S. Repurchase Agreement Market* document (OMB Number 1505–0259) issued by the Office of Financial Research. This document explains the submission format, expected values, and header information of all three reports. Additional information about data elements, input formats, and character limitations is listed in the Appendix A of this document.

## **Data Validation Checks**

Rules for validation checks are listed in the attached excel file in Appendix B. The file includes information on the data elements being analyzed, the validity test and type being performed, the algorithmic explanation of the test, and the Error Message Key and Error Message Display.

#### Data File Name

YYYYMMDD\_OFR\_SFT\_1\_GCT.txt – file naming standard for General Collateral Trades (OFR-SFT-1-GCT) file, where YYYYMMDD (ISO 8601) date format represents the observation date of the report.

YYYYMMDD\_OFR\_SFT\_1\_GCE.txt – file naming standard for General Collateral Net Exposure (OFR-SFT-1-GCE), where YYYYMMDD (ISO 8601) date format represents the observation date of the report.

YYYYMMDD\_OFR\_SFT\_1\_SST.txt- file naming standard for Specific Security Trades (OFR-SFT-1-SST), where YYYYMMDD (ISO 8601) date format represents the observation date of the report.
